Photography and Media Consent Agreement (Gift of Right of Publicity)

Thank you for visiting Hermann Park. The Hermann Park Conservancy often takes or commissions photos and videos of activities at Hermann Park for promotional, educational, and other legitimate purposes. To help advance Hermann Park Conservancy's charitable and educational purposes, please read below and indicate your consent and agreement.

SECTION 1: CONSENT AND RELEASE (ADULTS AND MINORS)

I irrevocably give, grant, and convey to Hermann Park Conservancy, its successors, licensees, agents, and assigns (collectively referred to as "**HPC**"), the unrestricted, royalty-free, and worldwide right and permission to take, use, re-use, publish, modify, and republish photographic portraits, video, and pictures of me or in which my image, likeness, or voice may be included, in whole or in part (collectively, "**Photos**"), without restriction as to changes or alterations, in conjunction with my name or a fictitious name, made through any medium and in any media now or hereafter known or developed, including for educational uses, marketing, public relations, electronic media, websites, social media, publications, promotions, over-air broadcasts, advertisements, and posters.

HPC shall have the right to use, copy, modify, adapt, distribute, publish, display, exhibit and otherwise use, either in whole or in part, the Photos or any of them for any lawful purpose, including for the promotion, marketing, or fundraising efforts of Hermann Park Conservancy. I waive any right to inspect or approve HPC's final product of any of the Photos.

I agree that Hermann Park Conservancy is the sole and exclusive owner of all right, title, and interest in all copyrights, trademark, and other intellectual property rights in the Photos.

For myself and any minor child(ren) disclosed below, I hereby RELEASE HPC and their respective officers, directors, employees, agents, licensees, assigns, and successors from any and all liability for rights, claims, or causes of action by me, any of the minor child(ren) listed below, or anyone claiming for, by, through, or under me or such minor child(ren) in connection with the Photos, including claims in connection with the taking, use, or publication of the Photos or use of name, likeness, image, or voice, including claims for invasion of privacy, defamation, false light, or misappropriation of name, likeness, or image.
